


LIMIT OF MODERATE WAVE ACTION (LIMWA). Zone AE has been divided by a Limit of Moderate Wave Action (LIMWA). The LIMWA represents the approximate landward limit of the 1.5-foot breaking waves. The effects of wave hazards between the Zone VE and the LIMWA (or between the shoreline and the LIMWA for areas where Zone VE is not identified) will be similar to, but less severe than, those in the Zone VE.

COASTAL BARRIER RESOURCES SYSTEM (CBRS)


