



Stream lines were provided by the USGS, water bodies and dams were provided by the Oklahoma Water Resources Board, HUC8 boundaries were provided by the US Department of Agriculture - Natural Resources Conservation Service, political boundaries were from TIGER files from the U.S. Census Bureau dated 2012, the Otoe-Missouria Tribe of Oklahoma boundary was provided by the Cherokee Nation Office of Environmental Services, railroad information was from the Federal Railroad Administration, road information was provided by the Oklahoma Department of Transportation - Office of Geographic Information and Technology Services, and the PLSS information was provided by the Oklahoma Tax Commission - Ad Valorem Division.
