

For community and countywide map dates refer to the Flood Insurance Study report for this jurisdiction.


To determine if flood insurance is available in the community, contact your insurance agent or call the National Flood Insurance Program at 1-800-638-6620.

The Capital Area Council of Governments (CAPOCO) provided base transportation and city limit information in digital format dating from 2002, 2004, and 2007. The City of Horseshoe Bay provided city limit information in a 2007 digital AutoCAD file. The Texas Natural Resources Information System (TNRIS) provided the Stratmap County Boundaries in digital format, dated 2005. The United States Geological Survey (USGS) provided 7.5-Minute Series Topographic Maps, dated 1989, and a digital version of the National Hydrography Dataset, dated 2005. LIDAR and contour data from 2007 were provided by the Lower Colorado River Authority (LCRA). The National Oceanic and Atmospheric Administration (NOAA) National Geodetic Survey (NGS) provided permanent bench mark data sheets from 2002.
