For community and countywide map dates refer to the Flood Insurance Study report for this jurisdiction.



Base map information shown on this FIRM was derived from digital orthophotography provided by the NAIP. This imagery was flown in 2015 and was produced at 1 meter resolution.


The AE Zone category has been divided by a Limit of Moderate Wave Action (LiMWA). The LiMWA represents the approximate landward limit of the 1.5-foot breaking wave. The effects of wave hazards between the VE Zone and the LiMWA (or between the LiMWA and the VE Zone for areas where VE Zones are not identified) will be similar to, but less severe than those in the VE Zone.
