For community and countywide map dates refer to the Flood Insurance Study report for this jurisdiction.



Base map files were provided in digital format by Kentucky Division of Geographic Information, dated 2011 and 2014, Kentucky Transportation Cabinet, dated 2006, and United States Geological Survey (USGS). Additional information was photogrammetrically compiled at a scale of 1:40000 from 1-meter resolution NAIP imagery dated 2012.


