


Base map information shown on this FIRM was provided in digital format by multiple agencies. The United States Census Bureau provided digital format of base transportation, dated 2013. Political boundaries were provided by the New Jersey Office of Information Technology, dated 2013. Laser Mapping Specialists, Inc. collected the LIDAR data between March and April of 2011. The New Jersey Office of Information Technology provided the ortho imagery for Burlington County, dated 2013.

NJFHADF is equal to the 1-percent-annual chance flood plus an additional 25% in flow, and not to exceed the 0.2-percent-annual chance flood. NJFHADF boundary is to regulate disturbance to the land and vegetation within flood hazard area of a water body. This regulation is set forth by the State of New Jersey Flood Hazard Area Control Act Rules N.J.A.C. 7-13, and is administered by New Jersey Department of Environmental Protection (NJDEP).
